Participants and their parents and/or guardians understand that dulled swords, shields, bamboo sticks, and like weaponry will be used at the camp and that all such tools must be handled with care by each individual participant as each may dangerous if mishandled. Participants and their parents and/or guardians accept the inherent dangers associated with participating in Gatka and using the tools of Gatka and acknowledge that they are participating of their own free will and at their own risk.</p> <p>California Gatka Dal is not responsible for any damage caused by or to personal property or for any damage caused to personal property in the course of the camp and the practice of Gatka.</p> <p>Hosts are not responsible for any type of medical injury or other condition that may arise during the course of California Gatka Dal camp and any other associated activity. The Participant and Participant's family hereby waive any rights to sue the Hosts with regard to any aspect of the Program and its associated activities and any resulting conditions or impact to Participants or their families, and releases Hosts of any liability in this regard.</p> <p>The parents or legal guardians of the Participant are responsible for bringing the Participant to California Gatka Dal activities and picking up the Participant afterwards.
